## Tract Description: (Combined Description for Tracts 1, 2 and 4)

A tract of land in the Southeast Quarter (SE/4) of the Southwest Quarter (SW/4) of Section 29, Township 2 South, Range 7 East of the 6th P.M. in Marshall County, Kansas, more fully described as follows:

Containing 2.31 acres more or less.
